Mr. Millwee has testified as an expert witness in the fields of premises liability, workplace violence, negligent hiring, retention, screening, security, polygraph, police procedures, and other forensic fields. He is a crisis management consultant to many American corporations, conducting violence and threat assessments. He is the author of *SecurViolence* and *SecurThreat*, custom threat assessment questionnaires. He is also the author of SecurHarass questionnaires that help employers conduct investigations of sexual harassment complaints.

Mr. Millwee is the inventor of iReviewNow (copyright protected and U.S. Patents 7,979,908, 8,646,101, and 9,183,363, the only background screening solution that

allows consumers to verify their own consumer reports in real-time, effectively mitigating all FCRA and EEOC-related claims. He is also the inventor of TerrorAlert (copyright protected and U.S. Patent Pending), which instantly identifies terrorist, violent, and other high-risk candidates, invitees, or others entering secure government and critical infrastructure facilities. He is also the author of *The SecurTest System*, which is comprised of 320 applicant and employment questionnaires. Mr. Millwee specializes in workplace violence prevention and intervention, crisis management, employee misconduct, such as theft or sexual harassment, and management and employee training to defuse the potential for workplace violence or employment liability.

The CPP (Board Certified in Security Management) distinction demonstrates a significant level of competency in the security profession verified through arduous testing, background qualifications, and the highest standards of professional conduct. Steve has been re-certified by the Professional Certification Board of ASIS every three years since 1995 by meeting its continuing education and ethical requirements. In 1998, he served on the ASIS CPP Role Delineation Committee, updating questions for their certification tests. Mr. Millwee performs site inspections for clients to mitigate the crime risk and claims of negligent security and premises liability.

Mr. Millwee lectures nationally on human resource and security issues. His highly rated lectures include topics on screening of applicants and employees, workplace violence, defusing disgruntled and violent workers, domestic violence, negligent security, employee theft, fraud prevention, IT security, employee investigations, hostage survival, robbery survival, negligent hiring and retention, interview and interrogation, leadership development, and written testing.

He was responsible for all murder investigations that remained unsolved for over six months. Mr. Millwee formerly worked for the Federal Bureau of Investigation in Washington, D.C.

In over 46 years of helping corporations, employers, and government agencies defuse hostile or threatening employees, no incidents of retaliatory violence have occurred when using the methods and counsel offered by Mr. Millwee. Moreover, *The SecurTest*

Mr. Millwee was a founding member of the Board of Directors for the Joint Council on Information Age Crime, whose primary mission was to help establish relationships between public and private sectors to secure critical infrastructures. Exemplar of Testimony and Opinions

The following is a sample of testimony and opinions that courts and legal counsel relied on over his four decades as an expert for plaintiffs and defendants.

Mr. Millwee was the expert witness at trial for the Plaintiff, SAMUEL BONILLA vs. TARANTINO PROPERTIES, INC., in the District Court of Harris County, Houston, Texas, in November 2022. The jury awarded Plaintiff \$40.25 million. who testify as to the foreseeability and the breach of the standard of care owed by the Defendant." Mr. Millwee provided detailed opinions about foreseeability, including the proximity of prior crime, recency of prior crime, the similarity of prior crimes, frequency of prior crime, and publicity of prior crime. The opinions and analysis mirrored a Timberwalk-type analysis. (Cause No. 50-2018-CA-007955; Melonie Whitted and River Swayngham vs. Southeast Centers; In the Circuit Court of The Fifteenth Judicial Circuit of The State of Florida, In and For Palm Beach County, Civil Division.)

Mr. Millwee was the expert witness for the Plaintiff in Harris County, Texas, concerning a premises liability and negligent security case. The "Plaintiff's Amended Designation of Experts and Supplemental Response to Request For Disclosure", reads: "Mr. Millwee is expected to testify about the risk and foreseeability of the robbery/shooting made the basis of this lawsuit, the likelihood of injury resulting from such a robbery/shooting, the social utility (or lack thereof) of the defendants' sexually oriented business, the magnitude of the burden of adequately guarding against such a robbery/shooting, and the consequences of placing this burden on the defendants." Mr. Millwee was the security expert in the high-profile case of the incapacitated patient who was raped and later gave birth at a Phoenix long-term care facility. Police arrested Nathan Sutherland, a nurse at Hacienda Healthcare, for sexually assaulting the 29-yearold woman, who had been in long-term care since age three after suffering a neardrowning. Sutherland's arrest resulted from a DNA match, among other evidence. The family had given orders to the facility years earlier that only female staff was allowed in the room after learning their daughter was the victim of sexual abuse. The investigation revealed that Sutherland had been alone with the patient hundreds of times. Treating physicians and nurses were unaware of her pregnancy until she was in labor. (Wendee Thompson, an incapacitated adult, by and through Mildred Salter, her mother and legal guardian and Joseph Thompson, her father; Mildred Salter, individually and on behalf of Wendee Thompson; and Joseph Thompson, individually and on behalf of Wendee Thompson vs. STATE OF ARIZONA; PHILLIP GEAR, JR., M.D. and JANE DOE GEAR, husband and wife; JUST FOR KIDS, P.L.C. d/b/a JUST 4 KIDS PEDIATRICS; THANH DIEP NGUYEN, M.D. and JANE DOE NGUYEN, husband and wife; INTERNAL MEDICINE CONSULTANTS, LLC. In the Superior Court of the State of Arizona in and for the County of Maricopa, Case # CV2019-057584.)

Mr. Millwee was the expert witness for the Plaintiff in Clearwater, Florida, concerning a premises liability and negligent security case. The deceased was the victim of a sexual battery while an invitee of the Defendant's resort. (Cause No 12-8339-CI; Shannon Doan as Personal Representative of the Estate of Laura Vincent by and on behalf of her minor children, Blakely Vincent and Avery Vincent vs. Jason Rapp and Shephard's Beach Resort, Inc., in and for the Circuit Court of the Sixth Judicial Circuit in and for Pinellas County, Florida.)

Mr. Millwee testified at trial in the murder of Jacob Cadriel by a co-worker. Millwee rendered several opinions before the jury, including the violation of the standard of care, failure to take reasonable steps to mitigate the murder, failure to verify the murderer's criminal record, and breach of the standard of care extended to invitees on the premises. The jury found for the Plaintiffs. (Cause No. 82139-CV; Erika Cadriel, Individually and as The Representative of The Estate of Jacob Matthew Cadriel and as Next Friend of Jacob Matthew Cadriel Jr., vs Steven Damien Young, Woven Metal Products, Inc., and Ind-Chem Constructors, Inc.; In the 412th District Court of Brazoria County, Texas)

At Cleveland Hopkins International Airport in Ohio, a taxi was taken by James Purcell, a Cleveland Police Department law enforcement officer. The cab driver, whose

extensive criminal illegal drug history was unknown to Sergeant Purcell, had been sleeping in the vehicle for hours that morning after smoking marijuana. When the taxi was being driven from the airport at excessive speed, the driver fell asleep, crashing the car. Sergeant Purcell sustained serious injuries. (James Purcell, et al. vs. Americab, Inc., et al - Case No. CV-07-624843 (State of Ohio, County of Cuyahoga).

A female trainee, Pearly Madison, was assigned to an independent contract truck driver by her employer for training. Despite his history of sexual misconduct, female trainees had been requested by the driver. After Ms. Madison was told she was beautiful by the driver, his advances were rebuffed by her. Threats were made by him regarding her employment. Subsequently, Ms. Madison was forcibly assaulted and raped by the driver during the trip. It was documented that prior complaints of sexual misconduct had been filed against the driver by another female trainee. Sexual relationships with trainees were known by the company to have occurred. The driver's violent criminal history was also known. Threats to supervisors had been reported to HR before Ms. Madison's assault. (Pearly Madison (Jane Doe) v. SWIFT Transportation Co. of Arizona, LLC Inc. and Murray WILLIS, Jr.; In the United States District, Middle District of Florida, Tampa Division; 8:21-CV-01576- VMC-CPT).

A pizza delivery company employee carried a 9mm Smith & Wesson 14-shot handgun making a delivery at a hotel in Atlanta, Georgia. Seven shots were fired at a maintenance employee by the driver, resulting in the victim's death, after what was believed to be a bag of marijuana was picked up in a hallway by the driver. Murder charges and multiple felonies involving the use of a deadly weapon during the attack were filed against the driver. The Plaintiff was struck by a commercial shuttle bus driver who failed to yield the right-of-way while riding his motorcycle. An Affidavit was provided to the court by Millwee for a Defendant regarding the employment and background investigation of the driver. A commercial driver's license was held by the driver, who had no disqualifying history when the accident occurred. Criminal, driving, and employment background checks were performed by the employer and its third-party commercial provider, with no disqualifying information found. Millwee opined that the Defendant met the standard of care when hiring the driver. The parties reached a settlement regarding gross negligence before jury instructions began.
